Improving Return on Investment in EHS

The need for judicious investment decisions has never been greater and its importance will keep growing with or without any pandemic disruption. I would like to share some of the areas from our recent experience that indicate potential areas for savings while implementing sound EHS Management Systems. In one case, the company lost its Quality Assurance (QA) personnel who was responsible for its Management System documentation. It also lost the soft copy of its documentation along with that because it was known only to that person. A simple discipline and regular check that documents are available on Shared Drives on Intranet or any other alternate system could have saved this. It led to the next QA professional spending two months in typing this from the hard copy. A simple reading from the hard copy using Microsoft Word in its latest version with "Dictate" feature could have saved at least 50% of the time. Also, other alternatives like scanning and

converting image or pdf document to Word would have saved much more time even if a paid version of Acrobat suite was taken. Similarly, many companies are spending large amount of EHS Software without adequately training the teams on how to use it. The lack of reliability of the data put into the system for compliance tracking and monitoring leads to hundreds of thousands and sometimes millions of rupees going waste and companies still get fined. In one case, the instances of groundwater extraction violation were not captured (intentionally or unintentionally) that led to closure of one of their units for a day. It also had to report this closure incident to Security Exchange Board of India (SEBI) leading to losses that could have been saved by using the tool judiciously.

The third example is that risk assessment is done multiple times in form of HAZOP, HIRA, PHA and Aspect-Impact Analysis for ISO 14001. Despite all these, the companies face a tough time when audits are carried out by investors through Environment and Social Governance (ESG) Assessors, and they start the whole exercise of risk assessment all over again. This leads to the wastage of resources. A cohesive Documentation Management System can help eliminate this multiplicity.

Above instances indicate some areas with a potential for improving results of investments being done on EHS.
